Administrative officers asked to strictly implement masks, social distancing, hand hygiene in their areas - Health Minister

Those who do not wear masks in public places will be challaned - Anil Vij  
Chandigarh, November 30 - Haryana Health Minister, Sh. Anil Vij said that keeping in view the spread of new Omicron variant of COVID-19 and the feared third wave of COVID-19, Deputy Commissioners, Commissioners of Police, Inspectors General of Police and Superintendents of Police of all the districts of the state have been given directions that they will ensure strict implementation of COVID-19 protocols such as wearing of masks, social distancing, hand hygiene etc. among the people in their respective districts and jurisdictions. In addition, where there is a possibility of congestion, like all schools, industries, business premises, railway stations, bus stands, etc., agencies like police, health, municipal and civic committees COVID-19 protocols will be strictly enforced by challaning those who do not wear masks in public places.

Sh. Vij was presiding over a review meeting of Health Department officers here today.

Sh. Vij directed the officers to make the general public aware in this regard through Munadi etc. at all the public places.

Sh. Anil Vij said that to deal with the new variant of COVID-19 identified by South Africa, Omicron and the possible third wave, the officers of the Health Department and related departments will have to be alert and increase testing by continuously making people aware to protect themselves against COVID-19.

Genome sequence of COVID-19 patient should also be done - Anil Vij

In the meeting, the officers apprised the Minister that genome sequence is needed to test the new variants identified by South Africa, for which a machine has been installed in Haryana. Sh. Vij said that, however, if a new patient of COVID-19 is found in Haryana, then genome sequence of the patient should be conducted so that other people can be saved from getting infected.

During the meeting, the Health Minister was apprised that about 12,000 COVID-19 tests are being done per day in the state and now it is being increased and a target of 40,000 tests per day has been set in the coming days.

Testing of passengers coming from 'at risk' countries should be done in the state- Vij  
Officers at the meeting pointed out that travelers arriving from countries in Europe including 'at-risk' countries such as the United Kingdom, South Africa, Brazil, Bangladesh, Botswana, China, Mauritius, New Zealand, Zimbabwe, Singapore, Hong Kong and Israel are being tested at the airport and those who are found negative are being tested by the Health Department teams on the 8th day to prevent the spread of infection. In this context, Sh. Vij directed the

COVID-19 testing should also be done for patients with Influenza Like Illness (ILI) – Vjj The Health Minister directed the officers that patients with Influenza Like Illness (ILI) should also be tested for COVID-19 so that the infection can be prevented from spreading. Officers said that in relation to COVID-19, the Health Department has enough essential medicines and so far 79 PSA oxygen plants have been set up by the Health Department in various hospitals of the state. Similarly, RTPCR labs are also being established in 22 districts of the state, out of which some of these labs are also operational in some districts. He said that the youth are benefitting from the drug de-addiction campaign jointly run by SP, Yamunanagar, Sh. Kamaldeep Goyal and various NGOs and he hoped that similar efforts are made in the whole of Haryana. Sh. Vij today interacted with the officials of various NGOs working in the drug de-addiction campaign in Ambala. The Home Minister said that the police is again steering the youth who have given up drugs towards the right ideology. Sh. Every effort will be made to bring the youth out of the drug trap. He said that at present many drug de-addiction centers are open at different places. Wherever the number of beds in these centres is less, the number of beds will be increased according to the requirement. Efforts will be made to open such centres in the areas where drug de-addiction centres are not available. It is worth mentioning that Yamunanagar Police has launched a campaign against drug addiction, in which on one hand the police is taking strict action against those who sell drugs, on the other hand drug addicts are getting rid of drugs and bringing drug addicts on the right path. In this programme 22 NGOs are also coordinating with the police. Sh. Kamaldeep said that till now 175 youths of Yamunanagar have quit drugs by joining this campaign of ours.

Chandigarh, November 30 - The purpose of Haryana Right to Service Act is to fulfil the maximum expectations of the common people with regard to rendering of services in a hassle free, transparent and time-bound manner which further facilitates the life of the common person. All the services and schemes of Government Departments focused towards public benefit are provided through online medium by uploading on Antyodaya Saral portal.

Giving information in this regard, Secretary, Haryana Right to Service Commission, Smt. Meenaxee Raj said that today, the Chairman of Commission, Sh. TC Gupta and the Principal Secretary to the Chief Minister, Sh. V. Umashankar held a review meeting with the Heads of Departments. It was decided in the meeting that the Head of the Departments should take the comments of the Administrative Secretary and Administrative Reforms Department of the concerned department before sending any proposal to the Commission.

Haryana Police arrests six on the charges of drug-peddling

Chandigarh, November 30 - The Haryana Police has arrested six persons including a woman on the charges of drug-peddling and seized 1-kg of opium, over 36-kg of ganja and more than 2-kg chura post in separate incidents in Kurukshetra, Sirsa and Bhiwani districts.

Sharing the details, a Haryana Police spokesperson informed that a police team in Kurukshetra had got a tip-off that a woman was attempting to smuggle ganja to addicts. After getting the information, police set up a barricade near Ravidass chowk and nabbed the accused woman. When searched, 6 kg 840 gm of ganja was recovered from her.

In another incident, a team of State Anti Narcotics Bureau in Kurukshetra had seized 2.100 kg of 'ganja' patti' from a person at a dhaba, who used to sell the drugs to truck drivers.

In a separate incident, a team of Anti Narcotic cell in Sirsa while patrolling and checking signaled a motorcyclist to stop for checking. Instead of stopping, both riders tried to speed off but were nabbed. On being frisked, 1 kg opium was recovered from their possession.

In another catch, a police team in Bhiwani had arrested two motorcyclists after it recovered 30-kg 130 gm ganja from them. On interrogation, the accused revealed that in order to earn quick bucks, they had bought seized ganja from a person at the rate of Rs 7000 per kg with Rs 2.10 lakh.

Cases under provisions of the NDPS Act were registered against them and further investigation was underway. Haryana Police is continuously cracking down on people involved in illegal trade of drug peddling across the state, he added.
